This Modern Slavery Statement is made pursuant to Section 54 of the Modern Slavery Act 2015. It outlines the steps MKA Solutions Ltd has taken and continues to take to ensure that modern slavery or human trafficking is not taking place within our business or supply chains.

#### **Our Business**

- **Supplier Code of Conduct:** We have established a Supplier Code of Conduct, which outlines our expectations for suppliers, including a zero-tolerance policy towards modern slavery.



## **Due Diligence Processes**

To identify and mitigate the risk of modern slavery in our operations, MKA Solutions Ltd has implemented the following due diligence processes:

- Conducting risk assessments to identify areas of potential risk in our supply chains.
- Engaging with suppliers to ensure they are aware of, and comply with, our Anti-Slavery and Human Trafficking Policy.
- Incorporating clauses in supplier contracts requiring compliance with the Modern Slavery Act 2015.
- Regularly reviewing and monitoring our supply chains for any potential risks related to modern slavery.

# **Training and Awareness**

We provide training to our staff to ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business. This training is mandatory for all employees, particularly those involved in procurement and supplier management.

## **Measuring Effectiveness**

MKA Solutions Ltd is committed to continuously improving our processes to combat modern slavery. We regularly monitor and review the effectiveness of our policies and procedures, and we set performance indicators to measure our success in preventing modern slavery in our business and supply chains.
